## **BACKGROUND**

This project is to upgrade electrical appointments in the meeting room of the library, including new lighting, an increased number of outlets, and upgrade of existing outlets. Also included is elevator pit work to install a phone line, lighting, and an outlet for a sump pump. This work will be part of a multi-part renovation project.

## **SCOPE OF WORK**

This scope of work is included as a guide and to identify the minimum service level expected from the successful Contractor. The library is seeking bids for upgrading the electrical appointments in its meeting room. The Contractor shall provide all materials, labor, tools and related services required for the performance of the contract. This includes removing and disposing of existing lighting, new LED lighting and wall spotlights with dimmer switches, replacement of existing electrical outlets, and addition of nine more electrical outlets. In the elevator pit, installation of lighting, a phone line, and electrical for a sump pump are required.

## **PROJECT TIMING AND AVAILABLITY**

The successful candidate or firm will agree to commence activity from the notice to proceed, which is anticipated to be on April 18, 2024. Project must be started within 30 days of bid award unless otherwise negotiated by the installer and the library. Installation must be scheduled with library and completed within two weeks of installation date selected. 25% penalty for each week delay.

#### **FORMAT AND SUBMISSION**

Submittal: All items requested as part of the RFP must be completed in their entirety. Failure to do so can result in the submittal being declared disqualified. The library must be in receipt of all Proposals by 5pm, Friday March 29, 2024 at the following address:
