## BACKGROUND

This project is to replace the carpeting throughout the meeting room of the library with professionally installed luxury vinyl tile.

## **SCOPE OF WORK**

This scope of work is included as a guide and to identify the minimum service level expected from the successful Contractor. The library is seeking bids for the installation of new luxury vinyl tile. The Contractor shall provide all materials, labor, tools and related services required for the performance of the contract. This includes removing and disposing of all carpeting and any carpet padding (if applicable), preparing the exposed surface for a smooth and successful vinyl tyle installation, and installation of new luxury vinyl tile (with padding and adhesive as needed). The tile requested is Interface Native Fabric LVT in A00806 Twine 50 x 50 cm. Measuring to be covered in the RFP question section. Enough tiles to cover routine tile replacement should be included in final total.

## PROJECT TIMING AND AVAILABLITY

The successful candidate or firm will agree to commence activity from the notice to proceed, which is anticipated to be on April 18, 2024. Project must be started within 30 days of bid award unless otherwise negotiated by the installer and the library. Installation must be scheduled with library and completed within two weeks of installation date selected. 25% penalty for each week delay.

Submittal: All items requested as part of the RFP must be completed in their entirety. Failure to do so can result in the submittal being declared disqualified. The library must be in receipt of all Proposals by 5pm, Friday March 29, 2024 at the following address:
